



2020 **VIRTUAL** TOUR OF REMODELED HOMES PARTICIPATION AGREEMENT

GENERAL INFORMATION

The 23rd annual **Tour of Remodeled Homes** (TOUR) sponsored by the Remodelers Council of the Greensboro Builders Association features professional residential remodeling.

Due to the pandemic, this year's event will be a **virtual tour only**. It is important as an industry to continue to promote and showcase professional remodeling. The annual Tour of Remodeled Homes provides an opportunity for our Association members to promote their renovation business as well as quality workmanship. It also provides an opportunity for suppliers and trade contractors to gain exposure as trusted industry partners.

ELIGIBILITY

Any active remodeler who is a member in good standing with the Greensboro Builders Association is eligible to participate. The remodeler must be current on both Association dues as well as Remodeler Council dues.

PROJECT REQUIREMENTS

There is no limitation on the number of years back the project was completed. Permits must have been properly procured and all satisfactory inspections achieved on the project. If the property was built prior to 1978, lead testing and renovation procedures must have been properly conducted.

Homeowner agrees to make the home available for a virtual tour of the renovation. In addition, they agree to allow the virtual tour video, as well as photographs of the before and after renovation, be used in marketing and promotions for the Tour of Remodeled Homes. If the homeowner provides prior consent, the remodeler can schedule appointments to show the home.

ENTRY FEE

The entry fee is determined in advance by the TOUR Executive Committee. The entry fee has been reduced this year, given we are doing a virtual-only event. Entry fees are used to promote and advertise the Tour of Remodeled Homes. The non-refundable entry fee of **\$750** is due by July 17, 2020.

MARKETING & PROMOTIONS

A promotional campaign will be launched by the TOUR Committee prior to the event. Your TOUR entry will be showcased in the digital TOUR Magazine; on the Greensboro Builders Association website; and on social media platforms promoting the Virtual TOUR. Information will remain on the GBA website Tour of Remodeled Homes page for up to twelve months.
