Acceptance of Membership Terms

Your remittance represents your annual membership dues in the Greensboro Builders Association (GBA). With payment you acknowledge that a portion of your investment covers your membership in the North Carolina Home Builders Association (NCHBA) and the National Association of Home Builders (NAHB). You agree to abide by the Constitution, Bylaws and Code of Ethics of all three organizations. Your application will be submitted to the Greensboro Builders Association Board of Directors for approval. Dues payments to the GBA are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expenses, subject to exclusion for lobbying activity. A portion of your dues used for lobbying by GBA, NCHBA and NAHB, \$54.78 is not deductible for a base membership of \$575 (33% NCHBA dues & 16% NAHB dues). In the event of termination/cancellation of membership in the Greensboro Builders Association, you agree to immediately discontinue use of its insignia in any form.
