Parade of Homes: Rules & Regulations

- Parade of Homes is an event open to the public promoting new construction. Open houses will be dependent on regulatory restrictions in place at the time of the event. If open houses are not allowed, we will proceed with marketing the Parade with virtual tours and the promotion of scheduled appointments to view Parade homes.
- There are two options for participation: Traditional Parade Open Houses with homes manned Saturday and Sunday, April 27-28 & May 4-5 from 1-5 pm providing all regulatory and CDC guidelines are followed OR participate with a Virtual Tour Only in which the home will not be open during Parade hours, however will be featured in the Parade magazine, on the website and mobile app.
- Participating builders must be Association members and maintain an active NC General Contractor's license.
- Parade homes must be owned by the builder and cannot be occupied prior to or during the Parade of Homes.
- All publication information, along with signed participation agreement and entry fee <u>payment</u> must be submitted no later than February 29, 2024.
 - Builder must submit high resolution electronic JPEG versions of **entry floor plan** (minimum 300 dpi) along with **front elevation / rendering**. *NOTE:* If incorrect elevation or floor plans are provided, builder is responsible for fees to have correct versions prepared.
 - Color renderings will be used in the magazine and mobile app. **Color selection sheet** must be completed by the builder and submitted with **front elevation / rendering.**
 - Builder must certify that the Parade entry is the result of an original design, and builder has obtained legal rights to use the design from the copyright owner and to the design as represented in the structure plans, specifications and drawings for the home.
 - Builders are required to submit a list of **Participating Trade Contractors & Suppliers** who assisted with the construction of the Parade house. GBA members will be listed on entry pages in the magazine.
- Builder must submit a certified price for each entry by February 29, 2024 which includes the lot cost as well as
 all actual costs to reproduce the same house. The price submitted for the magazine must be the selling price of
 the home, including lot cost, excluding furniture, draperies and free-standing appliances. All "built-ins" including
 built-in appliances must be included in the Parade price. No price changes after February 29, 2024.
- Parade homes must be held to the MLS listing price which will be the same as the listed price in the Parade magazine — for the completion of the Parade of Homes event.
- Builder must provide a **Certificate of Liability Insurance** with GBA named as Additional Insured.
- Cancellation of Parade entries prior to **February 29, 2024** may receive a partial refund. After February 29, 2024 no refunds can be provided.
- For homes still under construction, homes must be **SAFE** to be open during the Parade of Homes and must be noted as **UNDER CONSTRUCTION** in the Parade magazine. This requires homes to be trimmed and all accessible areas must have handrails for safety purposes. If Parade home presents a safety hazard to the public on the event opening date, builder agrees to remove Parade signage and not have the home open. *It is the builder's responsibility to advise construction status prior to March 22, 2024 for the Parade of Homes magazine.*
- For completed homes, builders are requested to provide a temporary CO no later than April 26, 2024.
- GBA will provide Parade of Homes sign for each entry and directional signs for homes that will be open. Directional signs are to be displayed in accordance with City and County regulations. Parade house signs are to be placed ONLY at Parade of Homes entries. Builder must return house and directional signs within ten days of the event. Signs not returned by **May 17, 2024** will result in \$100 invoice per sign.
- No alcoholic beverages are to be served on the property while the Parade of Homes is open to the public.
- Failure to comply with the above regulations will exclude the builder from Parade of Home privileges.
