



## 2026 TOUR OF REMODELED HOMES GENERAL INFORMATION

### OVERVIEW

Our *29th annual* Tour of Remodeled Homes (TOUR) sponsored by the Remodelers Council will be held in conjunction with the **Fall Parade of Homes** with open houses the first weekend **October 3-4, 2026**. Residential remodeling projects completed by members of the Greensboro Builders Association and Remodelers Council can be entered. Entries may be **traditional open houses** as well as **virtual tour only**.

The goal of this annual event is to promote professional remodeling, building greater awareness of the value and benefits of working with professional remodelers and trade contractors.

The **Fall Parade of Homes** will be held October 3-4 & 10-11, 2026 with the **Tour of Remodeled Homes open houses** the *first weekend only* - **Saturday & Sunday, October 3-4**. Hours are **1:00 – 5:00 pm** both days. Entries that are VIRTUAL TOUR ONLY will be noted as such in the *Parade / TOUR magazine* and on the website.

### ELIGIBILITY

Any active remodeler who is a member in good standing with the Greensboro Builders Association is eligible to participate. Further, the remodeler must be current on both Association as well as Remodeler Council dues.

### PROJECT REQUIREMENT

There is no limitation on the number of years back the project was completed. Permits must have been properly procured and all satisfactory inspections achieved on the project. If the property was built prior to 1978, lead testing and renovation procedures must have been properly conducted.

Homeowners agree to make the home available for a virtual tour of the renovation as well as an open house if preferred. In addition, homeowners agree to allow the virtual tour video, as well as photographs of the before and after renovation, to be used in marketing and promotions for the Parade of Homes / Tour of Remodeled Homes. With the homeowner's consent and signed agreement form, the remodeler can have the home open during the Parade/TOUR weekend.

### ENTRY FEE

Entry fees are used to promote and advertise the Tour of Remodeled Homes. The non-refundable entry fee of **\$1,000** along with entry paperwork is due by **August 1, 2026**.

### MARKETING & PROMOTIONS

A promotional campaign will be launched by the Parade of Homes Committee prior to the event. Tour entries will be showcased in the printed and digital *Parade of Homes* magazine; on the Greensboro Builders Association website; and on social media platforms promoting the Parade of Homes / Tour of Remodeled Homes. Information will remain on the GBA website Tour of Remodeled Homes page for up to twelve months.

## 2026 Tour of Remodeled Homes PARTICIPATION AGREEMENT

The goal of this event is to promote professional remodeling. As members of the remodeling industry, our greatest asset is our completed work. The TOUR is an opportunity to showcase the value of professional remodeling.

For good and valuable consideration which all parties acknowledge, and in return for the opportunity to participate in the Tour of Remodeled Homes, the Company agrees to the following:

1. In order to participate in any form of the Tour of Remodeled Homes, the Company must be a current member of the Greensboro Builders Association and Remodelers Council.
2. Projects are to be completed by **August 1, 2026**. If any part of the project is still under construction at that time, GBA is to be notified and a decision made on how to proceed. If the project will not be ready for photography, the Company must provide color renderings of the project for the ***Parade / Tour*** magazine. If any aspects of the proposed renovation project are outside stated criteria and requirements, project eligibility to be determined by the TOUR Executive Committee.
3. Homeowner Agreements must be signed for Open Houses as well as Virtual Tours by the homeowner and company representative.
4. For **Open Houses** during the **Parade of Homes / Tour of Remodeled Homes**:
  - a. Projects are to be open for public viewing during the **First Weekend Only** of the ***Fall Parade of Homes*** on **Saturday & Sunday, October 3-4** from **1:00 – 5:00 pm**.
  - b. The Company agrees to staff TOUR projects adequately during all hours of the open house. If not, the TOUR entry will not be allowed to be open to the public.
  - c. The Company will be responsible for setting up and removing TOUR entry and directional signs. All signage is to be returned to the GBA office following the event. If signs are not returned, the Company will be invoiced an additional \$100 per entry sign.
  - d. The Company agrees to have liability insurance in effect during the time of the Parade of Homes / TOUR of Remodeled Homes and will include a copy of the certificate with this entry application. The Greensboro Builders Association will be noted as an additional certificate holder.
  - e. The Company will provide a current and valid N.C. General Contractors License number associated with our project.
  - f. The Company attests that all building & trade permits were properly procured in the correct party's name and all inspections have been proper, timely, and satisfactory.
  - g. The Company attests that if the property was constructed prior to 1978 and the renovation was subject to the NC Lead Renovation Repair and Painting Act, lead testing and renovation procedures were properly conducted.

h. The Company will not allow any alcoholic beverages to be served on the property while the Parade of Homes / Tour of Remodeled Homes is open to the public.

5. For **Virtual Tours**:

a. The Company will coordinate with the homeowner and videographer to schedule a convenient time to conduct the virtual tour and/or photography of the renovation.

6. The TOUR entry fee is non-refundable and payable by **August 1, 2026**.

***By signing below, we acknowledge and agree to the terms set forth above in this Participation Agreement. The undersigned hereby agrees that any violation of the above requirements is subject to review by the Tour of Remodeled Homes Executive Committee and the Greensboro Builders Association. This action may result in loss of eligibility to participate in this year's event, or future Tour of Remodeled Homes.***

3. Allow photographs and virtual tours of the renovation to be used for publicity by the Greensboro Builders Association (GBA), the Parade of Homes / Tour of Remodeled Homes and/or the remodeler.
4. Allow for the display of additional signage in the home during the event.
5. The homeowner indemnifies and holds harmless the Greensboro Builders Association from any loss, liability, damage or costs, including attorney fees it may incur as a consequence of the Association's or other person's presence on the homeowner's property, which are caused by the negligence of the homeowner, and further recognizes that the GBA or its committees have no express or implied duties related to the Homeowner.

The undersigned Remodeler agrees to:

1. Maintain adequate staffing throughout the event's duration to ensure the homeowner's security.
2. Make every effort to protect the homeowner's property and possessions by sectioning off un-shown areas, protecting carpeting and landscaping, etc.
3. Clean the premises after the TOUR open house and remove all signs and literature.
4. The contractor assumes full responsibility for any and all risks of bodily injury, property damage or theft occurring on the homeowner's property.
5. The contractor indemnifies and holds harmless the homeowner and the GBA, its officers, employees and members (collectively the "Association"), and each of them, from any loss, liability, damage or cost, including attorney fees, they or any of them from any injury to the homeowner's person or property of theft thereof, which are caused by the negligence of the contractor.
